No manuscript can be accepted for publication until a completed Author Agreement is submitted. The promises in this Author Agreement are made in consideration of Emory University's willingness to consider the Manuscript (as defined below) for publication.

FOR THE AUTHORS:

The attached research manuscript, presently titled _____ ("Manuscript"), is written by and is an original creation of _____ ("Author"). Even though "Author" will be used in the singular form it refers to all the people that participated in production and creation of the Manuscript. The Manuscript is being submitted for consideration for publication in *EURJ*. Author represents and warrants that Author owns all copyrights to the Manuscript and thus understands and promises that Emory University ("Emory") will be fully indemnified for any legal damages or other monetary liability and any related expenses arising as a result of the Manuscript. If accepted for publication, Author agrees to give and hereby gives Emory a perpetual, worldwide, royalty-free, non-exclusive license to publish, reproduce, distribute, reprint, perform, publicly display and otherwise use the whole or any part of the Manuscript in any form or medium (now known or hereafter developed), including print and digital media. Author gives Emory (through the *EURJ*) the permission and the right to edit the Manuscript. *EURJ* will work with the Author to the best of its ability to publish an article in a form that satisfies both parties, although *EURJ* will have final authority to edit the Manuscript as necessary for publication.
